# A GUIDE TO COMPLETING THE LAST WILL AND TESTAMENT TEMPLATE



## **SCOPE OF ENGAGEMENT**




It is vital that you have a valid Last Will and Testament, outlining your clear and accurate wishes as to who and how your estate shall be devolved.

BDO Wealth Advisers has provided a Last Will and Testament template to assist you in setting out your wishes regarding the disposal of your estate. Should you choose to utilize the template to draft your Last Will and Testament, there are important considerations to bear in mind in order to put in place a valid Will:

- > You must ensure that your wishes and intentions are expressed accurately. If the template does not specify or accommodate all of your specific wishes, then you shall have the option to request a consultation with a BDO Wealth Advisers Legal Adviser (at an agreed fee) for an alternative draft of your Last Will and Testament.
- > In nominating an Executor to wind up your estate, you should consider appointing as Executor a relative or close friend who will, when the time comes, appoint an attorney or accountant he/she is comfortable with, to attend to the formal administration of the estate.
- > Care must be taken to comply with the requirements of the Wills Act as referred to in the next three paragraphs, in order to ensure that your Will is valid.
- > The Will must be signed on each page by yourself and 2 independent witnesses who are not named in the Will and are not the spouse of a person named in the Will.
- > You may complete the Will electronically, however the Will may not be signed electronically. The completed Will should be printed and signed in person by you and two competent and independent witnesses, in the presence of each other.
- If relevant wording is written into the blank spaces provided, this does not amount to a change or amendment, but should you make any changes or delete any words or sections of the Will, these should be signed by yourself and your 2 witnesses.
- > Once the Will has been signed, it must be kept in a safe place so that your family can locate the document when the time comes.
- > It is also practical to keep with your Will other relevant documents and information which may be required for the purposes of winding up your estate. Please refer to our "Personal Document Checklist".

Should any of the afore-going heirs predecease me without leaving descendants, then their share of my estate shall devolve upon the remaining heirs pro rata

## 5. MINORS

If any portion of my estate would otherwise devolve in terms of the aforegoing clauses on an heir who is under the age of 18 (eighteen) years at the time of my death, such heir's share of my estate shall not be paid to the Guardian's Fund but shall be paid to the lawful guardian of the heir, if the heir is a minor, who shall be entitled to accept the inheritance for the benefit of the heir and whose receipt shall be a sufficient discharge to my executor. The said party shall accept responsibility for investing the inheritance and applying it for the benefit of the heir until such time as the heir is sufficiently mature to assume responsibility for the inheritance, or the balance thereof. No trust shall be constituted in terms of this clause, and the aforesaid guardian or other party shall not be obliged to furnish security to the Master of the High Court or any other authority in respect of the inheritance.

#### 7. PROVISION OF FUNDS FOR BENEFICIARIES

Once they have satisfied themselves that there are sufficient funds in my estate to discharge all liabilities and duties payable by my estate, my executors shall be entitled to make such capital advances to any beneficiary from time to time as they in their absolute discretion may think fit.

#### 8. COLLATION

I direct that no heir shall be required to collate any amount/s donated to him or her by me during my lifetime.

#### 9. EXCLUSION OF COMMUNITY OF PROPERTY

Any benefit accruing to any beneficiary in terms of this Will and any Codicil hereto shall be absolutely excluded from any community of property, community of profit and loss or community of acquests which may at any time exist between him or her and any spouse, shall not be taken into account in determining accrual in the estate of any beneficiary who may at any time be married according to an accrual regime, and in the case of a female beneficiary, shall not be subject to the marital power of any spouse.

## 10. RESTRICTION ON ALIENATION

No rights or hopes of the beneficiaries under this Will and no part thereof shall be attachable by any creditor of any beneficiary or vest in his trustee in insolvency or be capable of being ceded, assigned, pledged or otherwise encumbered without the written consent of my executor and if any beneficiary shall purport to cede or assign such funds, or if any attempt be made by any creditor to attach or levy execution upon same, the right of such beneficiary to receive distribution of any funds in terms of this Will shall cease and be forfeited forthwith and shall devolve upon those heirs who would have been entitled thereto as if the heir in question had predeceased me.

- Please ensure when printing your Last Will and Testament that you print it single sided and not double sided. Print two copies.
- The competent and independent witnesses must not be mentioned in your Last Will and Testament. This includes your heirs, beneficiaries, spouses, trustees, executors, or any child.
- Sign each page of your Last Will and Testament, together with the signatures of two competent and independent witnesses on each page. Your Last Will and Testament must be signed in black ink.
- Please date your Last Will and Testament on the last page.

- Your signature and the two signatures of the witnesses should be the last thing seen on each page of your Last Will and Testament. No other clause or writing should be beneath said signatures.
