





#### Eliminating exposure by bringing clarity

Fraud is a global problem with an adverse effect on organisations and it is difficult to determine the full scope of losses as fraud is often undetected and sometimes never reported. According to the Association of Fraud Examiners (ACFE) Report to the Nations (2020 Global Study on Occupational Fraud and Abuse) and research across 125 countries and 2 504 cases, it is estimated that losses of an estimated \$3.6 billion arise from occupational fraud.

Over the 30 years our team has been conducting forensic investigations, we have observed various instances of corporate fraud that have been committed by employees, either acting alone or with outside accomplices, such as suppliers. 
#### WHISTLEBLOWING

BDO offers a fully integrated whistleblowing mobile application for companies to promote and manage whistleblowing called BDO Tipoffs, powered by EXPOSEIT. The application ensures complete anonymity and a continuous method of communication with the whistle blower to update them on the status of their report. The application is easy to use and allows the user to upload and send video files, photographs, documents, locations, and other forms of evidence without fear of being identified. The system also has the functionality to send general broadcast notifications to the entire user base within a company.

The application allows anonymous communication by way of a simple report or a two-way conversation with a trained, independent moderator who will debrief the reporting user and assist them as appropriate.
